How is a True Estimate created?

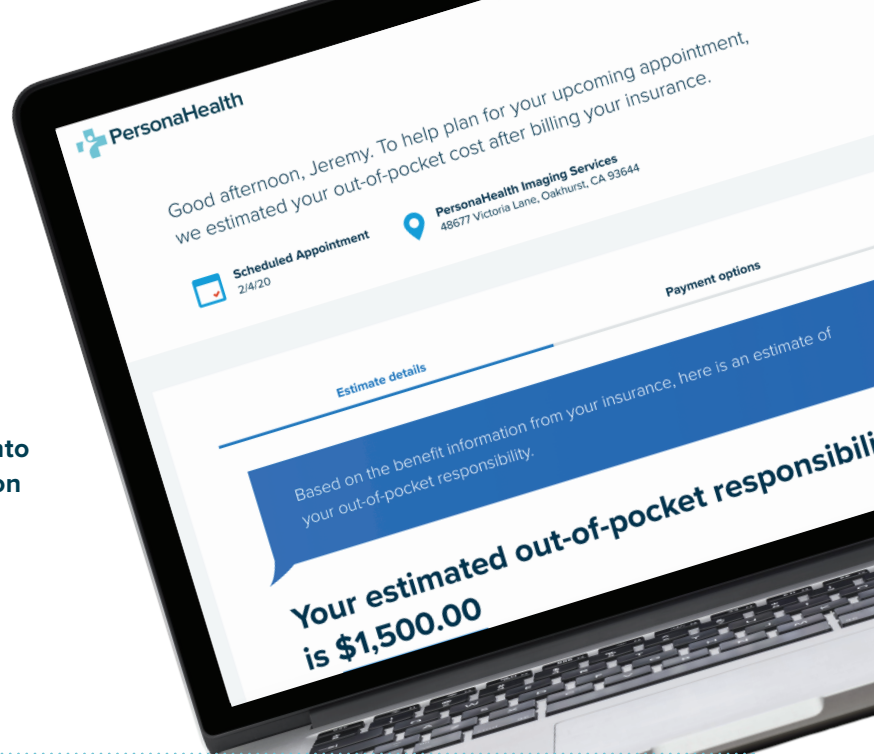
True Estimate determines the patient's financial liability by using the hospital's chargemaster (CDM) and the contracted payer rates. It combines the chargemaster amount, the contracted payer rate, and the patient's insurance benefit details to calculate the patient's financial responsibility after insurance. It also implements logic to apply prompt-pay and self-pay discounts when arranging for payment.
